RULES and FEES

TRANSFER OF RECORD OF OWNERSHIP

- A. An official Transfer Application must be correctly completed and submitted to TLMHR, Inc. with the appropriate fee upon every change of ownership of the registered Lippitt.
- B. Any person applying for transfer of a Lippitt may be required to furnish (at applicant's expense) blood type reports or DNA analysis reports, other additional information, documentary, or evidence TLMHR may deem appropriate
- C. The official registration certificate for the Lippitt being transferred must be submitted with the application for transfer.
- D. Whenever legal title of a registered Lippitt passes to another person by reason of death of the recorded owner, foreclosure of any lien, by any order or decree of court, or otherwise by operation of law, TLMHR may transfer the registration of the subject Lippitt to the new owner:
 1. Upon court order of competent jurisdiction or other satisfactory proof of authority for transfer.
 2. Upon payment of the transfer fee.
 3. Upon satisfaction of such other requirements as may be required by the Registrar.
